

EVENT REPORT 2024 – JEAN MONNET MODULE – UNIVERSITY OF VALE DO ITAJAÍ-BRAZIL



In this report, the outcomes of the Jean Monnet Module at the University of Vale do Itajaí for the year 2024 are presented. Among the goals of the Module for the year was the organization of an International Seminar, involving professors, researchers, and experts in migration law from Brazil and Europe, as well as from Latin American countries, to promote joint discussions on the topic.

The **objectives** of the organized event were:

- 1- Provide a space for interaction between postgraduate programs and entities specialized in migrant assistance, fostering interaction between theory and practice, comparing the realities of Europe and Latin America;
- 2- Establish cooperation programs between Brazilian and international postgraduate programs, with joint publications and comparative debates on addressing transnational migration issues, bringing the European reality into the publications;
- 3- Develop a platform for debate to enhance the social engagement of postgraduate studies in scientific research and problem-solving proposals concerning the social, cultural, political, and economic vulnerability of many immigrants and refugees, from a European and Latin American perspective;
- 4- Compare the migration realities of Latin America and Europe, jointly reflecting on the treatment of migrants considering the universality of human rights in migration matters, the repudiation and prevention of discrimination, the non-criminalization of migration, humanitarian reception, equal treatment and opportunities for migrants and their families, social inclusion, labor and productive integration of migrants, and reflect on migrants' access to services, programs, and social benefits, public goods, education, public legal assistance, employment, housing, banking services, and social security;
- 5- Address the implications of migration for Brazil's economic, tourism, social, cultural, sports, scientific, and technological development;
- 6- Clarify paths to discern public policies and actions aimed at the inclusion of migrants and refugees in Brazilian and European societies, their formal labor market regularization and income generation, and access to civil, political, social, cultural, and economic rights.

The **justifications** for holding the event were as follows:

- 1- The event addressed the migration reality of both the American and European continents, as well as practical actions regarding the enforcement of human rights for migrants and reflections on public policies related to the migration phenomenon. It thus covered the challenges of refugee life and the rights that protect them; international law, the Organization of American States, the UN, and the European Union in their work to protect migrants and refugees; the challenge of migration, intercultural democracy, and climate change; the legal consequences of migration due to the war in Ukraine; the actions of the Brazilian Judiciary in relation to the demands of migrants and refugees, comparing it to the European perspective.
- 2- The event held great relevance for scientific research, as it provided a platform for high-level academic debate and fostered the development of qualified postgraduate partnerships between

national and international researchers. Furthermore, the proposed topic will result in an e-book, publishing book chapters that will compile all the knowledge produced during the event, allowing for an understanding of the migration treatment in both Brazilian and European contexts. This will contribute to the improvement of the quality of scientific production in Brazilian postgraduate studies, with strong encouragement for research and internationalization, which is highly valued by the Jean Monnet Module.

The audience benefited from the event due to the following contributions:

1- The event provided an opportunity for updates on contemporary debates within the academic communities of Latin America and Europe on the topic of migration, allowing for an analysis of the challenges of globalization through a comparison between European and Brazilian realities.

2- It created an academic space involving researchers, professionals in the field, professors, and students from postgraduate programs, which is useful for the exchange of ideas, scientific grounding, and the establishment of partnerships, enabling a better understanding of the functioning of the European Union.

3- It proposed contemporary reflections on the global and migratory crisis in relation to the Constitutional State and democracy, with suggestions that could generate thoughts on solutions to this crisis, viewing the issue from the perspective of the European Union and Latin American realities.

4- It disseminated intellectual resources for a new frontier of knowledge, which is demanded by the challenges posed by globalization in terms of constitutionalism and democracy.

5- It offered practical responses to the issue of transnational migration, enabling professionals to provide well-founded justifications with scientific rigor and conclusions with practical application.

6- It built up-to-date knowledge to address theoretical gaps in the legal foundation of transnational migration law, equipping professionals to manage the multiple legal, socio-anthropological, and economic challenges linked to migratory phenomena, within the perspective of the European Union and the realities of Latin America.

Presentation of the Migrant Support Center to the Italian Speakers, who addressed the European Union

European professors Prof. Dr. Maria Chiara Locchi, Prof. Dr. Massimiliano Minelli, and Prof. Dr. Jacopo Paffarini conducted a technical visit to the Migrant Support Center at the University of Vale do Itajaí and contributed to creating a comparative perspective with Europe. This visit was significant for initiating a study on the possibility of establishing an international university extension project between the University of Vale do Itajaí and the Università degli Studi di Perugia.

This extension project at the University of Vale do Itajaí serves 3,000 migrants annually and provides the following services:

- a) Provision of specialized, multilingual, consular-like assistance to migrants, with guidance on migration regularization and access to rights for social, cultural, labor, and economic inclusion;
- b) Legal guidance for migrants;
- c) Health access guidance for migrants;
- d) Promotion of workshops, seminars, or training sessions on human mobility, migrants' rights, and access to education, health, social assistance, work, culture, and other areas, aimed at public agents as well as professionals working with migrants and migrants themselves;
- e) Promotion, dissemination, guidance, and coordination, in partnership with public authorities and civil society, for the inclusion of migrants in the labor market;

f) Production and compilation of data and information about the migrant population served, to support the formulation of public policies at the municipal level, as well as organizing information on migration and publishing the processed data in the form of e-books, brochures, technical reports, etc.

The above-described activities are related to the following Sustainable Development Goals (SDGs): 4: Quality Education, 10: Reduced Inequalities, 16: Peace, Justice, and Strong Institutions, and 17: Partnerships for the Goals. This proposal allows the knowledge produced at the University to be applied to public authorities and society's urgent needs.

Thus, a context of advancement and deepening of knowledge in the migration field is developed, addressing concrete and real problems, while providing services that represent a solution to the challenges faced by the state of Santa Catarina in migration matters.



Jean Monnet Open Course

The Jean Monnet Module at the University of Vale do Itajaí promotes education on the functioning of the European Union system and European Community law to Brazilian students. The course covers migration and asylum law in Europe: national and supranational profiles – Introductory notions: fundamental concepts and terminological distinctions. It provides an overview of the sources system (national, supranational, international) on the subject of migration and asylum. It also discusses the structure of competences in the governance of the migration and asylum phenomenon. The course consists of 40 hours in a hybrid format, with both in-person and online sessions streamed via Teams.

The **objectives** of the Jean Monnet Module open course are as follows:

a) Train professionals to develop or implement legal and policy strategies in addressing transnational migration issues and migrants' transnational rights, considering the specificity of the European reality, with high theoretical and practical qualifications, fostering critical, analytical, and proactive abilities.

b) Understand how the European Union deals with migration issues to develop an enhanced vision capable of responding to complex questions raised by migration in a globalized world, preparing professionals to face the speed of globalization, the dynamic pace of technological evolution, and increasing demographic mobility, while being aware of the social, cultural, innovation, and market demands that characterize contemporary society.

c) Understand the practical responses to transnational migration proposed by the European Union, enabling academics to provide well-founded justifications with scientific rigor and conclusions with practical application.

d) Build up-to-date knowledge to address theoretical gaps in legal understanding concerning transnational migration law, considering the European reality, and enabling the management of multiple legal issues, as well as socio-anthropological and economic matters related to migratory phenomena in Europe.

e) Develop a study that is not merely technical, considering the complexity of the transnational migration phenomenon, through an integrated approach capable of capturing and valuing the interconnections between the various areas of knowledge involved in understanding and regulating international migration (such as law, economics, sociology, anthropology, etc.), which also includes practical and essential training.

The open course has not yet concluded; the teaching activities will end on October 28, 2024.

The Jean Monnet course is divided into **5 modules**, as outlined below:

Module 01 – Train professionals to develop or implement legal or policy strategies to address



transnational migration issues and migrants' transnational rights through the study of the European Union.

Module 02 – Understand how the European Union deals with migration issues to develop an enhanced vision capable of responding to complex questions generated by migration in a globalized world.

Module 03 – Understand the practical responses to the issue of transnational migration proposed by the European Union, enabling academics to provide well-founded justifications with scientific rigor and conclusions with practical application.

Module 04 – Build up-to-date knowledge to address theoretical gaps in legal understanding concerning transnational migration law, based on the reality of the European Union.

Module 05 – Develop a study that is not merely technical, considering the complexity of the transnational migration phenomenon.
